MEMORANDUM OF UNDERSTANDING (MOU)

ON

Exchange of Students/Staff/Faculty

This Memorandum of Understanding (MOU) is effective as of / /2021 (effective date)

to establish an affiliation by and between.

Late Ku. Durga K Banmeru Science College, Lonar, Dist. Buldhana, has an academic excellence and achievement. It was established in June 2000 by Amrut Sevabhavi Sanstha Parbhani. The college is affiliated to Sant Gadge Baba Amravati University, Amravati. The College was accredited by NAAC with 'C' grade in Sept. 2016.

And

Shri Dnyaneshwar Maskuji Burungale Science and Arts College, Shegaon, Dist. Buldhana was established in September 2000 and Arts College in June 2003 by Late Reverend Father Shri. Maskuji Biruji Burungale Education Society. The College is accredited by NAAC with 'B' grade and affiliated to Sant Gadge Baba Amravati University, Amravati. Now college is a leading educational institute in university having Art's and Science disciplines.

PREAMBLE

Late Ku. Durga K Banmeru Science College, Lonar, Dist. Buldhana and Shri Dnyaneshwar Maskuji Burungale Science and Arts College, Shegaon, Dist. Buldhana and have many areas of common interest in Sciences, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research. Now Therefore, Both the colleges have decided to enter into this Memorandum of Understanding (herein after referred to as MoU). Which defines the framework for the cooperation of the two institutions set out in the following sections.

ARTICLE 1: OBJECT

Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity. The two institutions shall seek to promote:

a. Faculty/Scientist/Staff Exchanges

- i. The exchange of faculty to the mutual benefit of both institutions.
- ii. Collaboration in teaching. Research and development, and consultancy studies in the field of mutual interest.
- iii. The exchange of academic materials and publication.
- iv. Conducting lectures.

c. Other Areas:

- I. To exchange information on teaching, learning material and other literature relevant to their educational and research programs.
- II. The provision of cultural and intellectual enrichment opportunities for staff and students of both institutes.
- III. To use laboratory facilities in specific cases for a limited period.
- IV. To permit students, staff and faculty members to use library facility.

Late Ku. Durga K Banmeru Science College, Loar, Dist. Buldhana and Shri Dnyaneshwar Maskuji Burungale Science and Arts College, Shegaon, Dist. Buldhana agree that detailed terms and conditions that guide each activity identified above will be determined separately and agree upon by the two institutions. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation.

ARTICLE 2: COORDINATION

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf . Further, a coordination committee consisting of a programme coordinator from the side of Late Ku. Durga K Banmeru Science College, Lonar, Dist. Buldhana and a programme coordinator from the side of Shri Dnyaneshwar Maskuji Burungale Science and Arts College, Shegaon, Dist. Buldhana will periodically review and identify ways to strengthen cooperation between the two institutions.

ARTICLE 3: CONFIDENTIAL INFORMATION

Late Ku. Durga K Banmeru Science College, Lonar, Dist. Buldhana and Shri Dnyaneshwar Maskuji Burungale Science and Arts College, Shegaon, Dist. Buldhana will not absolve any confidential information during the research activity.

ARTICLE 4 : INTELLECTUAL PROPERTY RIGHTS

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MoU shall be vested in both institutes to this Memorandum.

Both institutes shall have the joint right to determine the commercial exploitation and disposition of such intellectual property and both institutes shall make joint applications for

- v. Undertaking joint research.
- vi. Attachment of staff for purposes of curriculum development and review, attendance of courses, upgrading of teaching and research skills
- vii. Participating in seminars, symposiums, and other types of academic discussions.
- viii. Conducting study tours and joint consultancy work.

A specific plan will be worked out for each activity: setting forth detailed arrangements for collaboration will be agreed. Terms and conditions for each visit or an assignment of such exchange, including those concerning salary, travel funding. A separate agreement will be entered into giving such details including terms of exchange of any intellectual property.

b. Student Exchange

Both institute's agree that students exchange will be guided by principles listed below. A home institutions refers to the institution where a student is a full-time student, and from where he/she is expected to graduate.

- a) Exchange students will be selected by mutual agreement between the home institution and the host institution.
- b) An exchange student will continue to be treated as full-time student at his/her home institution.
- c) If an exchange student has undertaken research, then the host institution will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a technical "report" of the research carried out.
- d) If an exchange student has undertaken research, then the home institution will take note of the performance evaluation and the technical report, and take steps in accordance with its own procedures.
- e) Both institutes agree to provide suitable accommodation and living expenses for student exchange.
 - 1) To avail travel expenses, students can apply for existing funding programs at their respective institution.
- g) The exchange students will pay tuition and other fees at their home institution.

the registration of the same. Before any registration or commercialization of any intellectual property takes place, the institutes agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing. Any publication regarding such intellectual property shall only be possible with the prior written consent of both institutes, such consent not to be unreasonably withheld. Both institutes shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, clinical and publication purposes without the payment of royalties or their fees to the other party.

ARTICLE 5: VALIDITY

The Memorandum shall remain in force for a period of THREE years commencing from effective date. Institutions may extend the term by written agreement signed by both after review.

ARTICLE 6: TERMINATION

Either the institution may terminate the MOU by giving written notice of six months in advance to the other institution. Once terminated neither Late Ku. Durga K Banmeru Science College, Lonar, Dist. Buldhana nor Shri Dnyaneshwar Maskuji Burungale Science and Arts College, Shegaon, Dist. Buldhana will be responsible for any losses, financial or otherwise, which the other institution may suffer. However, both institutes will ensure that the provisions of this memorandum shall continue to apply to all activities in progress until their completion.

ARTICLE 7: AMENDMENTS/MODIFICATIONS

This MOU may be amended or modified by a written agreement signed by the representatives of both institutes.

ARTICLE 8: ADHERENCE TO LAWS

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the law of the host countries and rules and regulations of the institutions.

ARTICLE 9: LEGAL EFFECT

Nothing in this Memorandum shall be constructed as creating any legal relationship between the institutes. This memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

ARTICLE 10: DISPUTE RESOLUTION

In case there be a dispute relating to any aspect of academic cooperation, Late Ku. Durga K Banmeru Science College, Lomar, Dist. Buldhana and Shri Dnyaneshwar Maskuji Burungale Science and Arts College, Shegaon, Dist. Buldhana will jointly resolve the disputes in a spirit of independence, mutual respect and shared responsibility.

Late Ku. Durga K Banmeru Science College, Lonar, Dist. Buldhana and Shri Dnyaneshwar Maskuji Burungale Science and Arts College, Shegaon, Dist. Buldhana welcomes the establishment of this memorandum for cooperation and jointly agrees to the provisions as set out above.
