Banmeru Science College Loni road - Lonar, Buldhana, Maharashtra, India is herein referred as LKDKBSC shall be represented by the Principal/ his nominee/ Delegated person. Further, with a view to enhance academic excellence and share the knowledge, skills in the field of higher education as well as to initiate exchange & co-operation between the concerned institutions, both the parties have agreed as follows.

Article I

Objective

The objective of this Memorandum of Understanding is to develop educational cooperation on the basis of reciprocity, mutual benefits, and to promote innovative mindset, skill development and entrepreneurship among rural student community in particular and in general affiliated to either parties.

Article II

Areas of Cooperation

1. The Parties shall encourage, as appropriate the development of contacts and cooperation for the mutual benefits. These may include all or some of the following activities.

- Exchange of Students;
- Collaborative Activities;
- To Conduct Workshops/Seminars;
- Organizing Training Programs concerning Soft Skills;
- Exchange of Teachers;
- Any other activity as agreed upon by the Parties in writing.

Article III

Executive Responsibilities

As per the agreement, the parties shall designate appropriate individuals, resources for smooth conduct of activities identical therein.

Article IV

Implementation

The implementation of cooperation activities within the terms of this Memorandum of Understanding shall be subject of specific arrangements concluded between the parties on the basis of and within the provision of present Memorandum of Understanding. However, at least two sessions in the Academic Year need to be taken. The aforesaid activities are to be properly planned and formulated in consultation between the two parties.

Article V
Financial Arrangements

Looking to the modern educational scenario; in fact indeed it is win win situation for both, the parties have agreed to enhance skill, talent, etc. of student by virtue of this Memorandum of Understanding. Both shall deliver the activities within their full intellectual strength and make the necessary arrangements in full shape.

Article VI
Amendment

Either Party may request in writing for a revision of or amendment (if any) to this Memorandum of Understanding. Such a revision or amendment shall come into effect on such a date as may be determined by both parties and shall form an integral part of this Memorandum of Understanding.

Article VII
Relinquish

Always it is open to revamp this Memorandum of Understanding in the interest of both the parties and students, concerning to the interpretation of implementation of this Memorandum of Understanding through consultation and negotiation by the parties. Even if both the parties desire to withdraw this Memorandum of Understanding, they can do so, by due process through mutual understanding.

Article VIII
Commencement, Duration, and Termination

- i) This memorandum of understanding comes into effect from the date of its signing & shall remain in force initially for Two Years. Its validity may be extended further by mutual consent between the two parties.
- ii) This Memorandum of understanding may be revised from time to time or may be terminated only in consultation with each other.
