## Sub :- Govt. Resolution of Department of Social Justice & Special Assistance on Revision of Pay scales & conditions for full-time Teachers/Librarians and other academic staff in Social Welfare colleges (aided and unaided) as per 7<sup>th</sup> Pay Commission and UGC Regulation – 2018- Direction – 2022

Whereas, the Government of Maharashtra, Higher & Technical Education has extended  $7^{th}$  Pay Commission vide Government Resolution No. Misc- 2018/C.R.-56/18/UNI-1, dt.  $8^{th}$  March, 2019 and  $10^{th}$  May, 2019 (University Direction No. 08/2019 and 14/2019) against UGC Regulation ó 2018, to the University/Colleges teachers and other academic staff in which the teachers and other staff in Social Welfare college were not included.

## AND

Whereas, now the Government of Maharashtra, Department of Social Justice & Special Assistance, has extended the 7<sup>th</sup> Pay Commission and other conditions in favour of full time teachers and other academic staff in Social Welfare colleges (aided and unaided) in the Universities in the State vide Government Resolution No. Sakam ó 2019/C.R.81/Samasu dt. 22<sup>nd</sup> October, 2021. However, unaided colleges will not be entitled for any financial assistance from the Government and aided colleges will only receive government assistance limited upto the approved posts by Government from time to time.

## AND

Whereas, the matter pertains to be regulated by Statute u/s 71 (20), 105 (10) of Maharashtra Public Universities Act, 2016, prescribing of which is time taking process, thereby for immediate action the Direction u/s 12 (8) of the Act is required to be issued for which the Vice-Chancellor, on behalf of Management Council, u/s 12(7) of the Act has noted the Government Resolution on 17/12/2021.

Therefore, I, Dr. Vilas Bhale, Vice-Chancellor of Sant Gadge Baba Amravati University, Amravati in exercise of powers vested in me under section 12 (8) of Maharashtra Public Universities Act, 2016 do hereby issue the following Direction :

1. This Direction may be called õGovt. Resolution of Department of Social Justice & special Assistance on Revision of Pay scales & conditions for full time Teachers/Librarians and other academic staff in Social Welfare colleges (aided and unaided) as per 7<sup>th</sup> Pay Commission and UGC Regulation ó 2018- Direction ó 2022.ö

2. This Direction shall come into force w.e.f. the date of its issuance.

3. In this Direction; unless the context otherwise requires;

(i) õActö means õMaharashtra Public Universities Act, 2016ö

(ii) õCollegesö means õaided and unaided Social Welfare Colleges affiliated to this Universityö

(iii) õFull time Teacher/Librarianö means õTeachers as defined u/s 2 (61) of the Act,ö

(iv) õGovernment Resolution ö means õGovernment Resolution No. Sankam ó 2019/C.R.81/Samasu dt. 22<sup>nd</sup> October, 2021ö of Department of Social Justice & Special Assistance, Government of Maharashtra, made applicable to improve the standard in social work colleges, which is available on Government website for Government Resolution.

(v) õUGC Regulation ö means õUGC Regulation ó 2018 as accepted by Government of Maharashtra Higher & Technical Education Department, vide Government Resolution No. Misc- 2018/C.R.-56/18/UNI-1, dt. 8<sup>th</sup> March, 2019 and amendment vide Government Resolution of even No. Misc. 2018/ C.R.56/18/UNI-1 dt. 10<sup>th</sup> May 2019 upon which Direction No. 8/2019 and 14/2019 respectively have been issued by the Universityö available on University website.

4. The provisions in Government Resolution mentioned above at 3 (iv) shall prevail and the provisions made in earlier Statutes, Ordinances, or Regulations, Directions etc. for the matters included in the said Government Resolution, to the extent to which they are inconsistent be invalid.

5. All Colleges/Institutions of Social Work affiliated / recognized by the University, shall take necessary action accordingly to implement the above Government Resolution No. Sakam ó 2019/C.R.81/Samasu dt. 22<sup>nd</sup> October, 2021 issued by the Department of Social Justice & Special Assistance Government of Maharashtra Mumbai, to full-time Teachers/Librarians and other academic staff as per the said Government Resolution in their Colleges/Institutions.

6. As per the said Government Resolution Unaided colleges will not be entitled for any financial assistance from Government and aided colleges will only receive Government assistance limited upto the approved posts by Government from time to time.
